Accessing the Charlotte-Mecklenburg Government Center (CMGC)

CMGC is located at 600 East Fourth Street at the corner of Fourth and Davidson streets in Uptown Charlotte. Parking is available in the CMGC parking deck located on Davidson Street between Third and Fourth streets. Parking tickets from the CMGC deck can be validated by CRTPO staff if they are brought to the meeting.

From the parking deck, there are two ways to enter CMGC. The primary entrance is accessed using the large staircase on the Davidson Street side. The handicapped entrance is on the ground level to the left of the stairs on the Davidson Street side. Everyone who enters CMGC undergoes a security screening, after which they may proceed to room 280 on the second floor. See next page for a diagram of the second floor area.



Tips for Remote Participants

- If joining after meeting attendance has been taken, please type your name and jurisdiction in the Chat Box so we have a record of your presence.
- Make sure you are in a quiet area.

- Never put your phone on hold.
- When speaking, keep your points clear and concise.
